Sub-committee Reports

Superintendent Contract Sub-committee

The Superintendent Contract Sub-committee met on January 16, 2018. Members present were Mr. Capobianco, Mr. Martucci, and Ms. Powell. Attorney Paul Hodnett was also present. The committee met in Executive Session.

Budget Sub-committee

The Budget Sub-committee met on January 30, 2018 and February 5, 2018 at 4:00pm. School committee members present were Jennifer Powell, James Fabiano and Gus Martucci. Others in attendance were Lisa Howard, Susan Eccles, Karin Chavis, and Barbara Flavin. The FY 19 Budget was discussed. No votes were taken.

Policy Sub-committee

The Policy Sub-committee met on February 12, 2018 at 5:30pm. Members present were Brian Perrin and Jennifer Powell. The Chemical Violation Policies were reviewed. No changes were made. The Tobacco Use Policy was reviewed. No changes were made. There was discussion regarding an update in the Substance Use Prevention and Education Policy. There was a request to change "Students in grades 8 and 10 will participate in state mandated SBIRT.... to "students in grades 7 and 9." The change was approved, and the policy sent to the Winthrop School Committee for a first reading and final approval. The subcommittee reviewed the naming policy and recommended no changes. Discussion was held on whether to have a moratorium on accepting nominations. No vote was taken. The subcommittee discussed endorsing the proposed Public Health Committee tobacco regulation changes including raising the age of tobacco sales. The matter was postponed to obtain more information. There was a unanimous vote to change Substance Use Prevention and Education Policy as requested so it will state "Students in grades 8 and 10 will participate in state mandated SBIRT..." There was a unanimous vote to make no changes to the Naming Policy. There was a unanimous vote to gather more information regarding Winthrop Public Health Tobacco Regulation Changes.

Superintendent's Report

Mrs. Howard reported that HMF&H requested a site visit regarding the pipe leak at the Middle/High School. We had to take down a portion of the wall. Our insurance company has looked at the damage and approved all the original subcontractors to do the work. The drywall and the stage are the biggest cost items. We're working with Gilbane also. The stage should be done this week.
