A public hearing of the 2019-2010 school budget was held on Monday, April 27, 2020 via Zoom Conference. The Chair called the meeting to order at 6:05pm.

#### PUBLIC COMMENT

- Christine Van Wart: Thank you for considering my pre-k refund. While I really loved sending my son to the 3-day program and it was a tough financial decision to make, I decided to send him and work hard to make the payments necessary. He missed the kindergarten cutoff, so it was best to send him to your pre-k program even though it was hard on our budget. With that being said, we fell into a situation towards January and February, once holidays hit, that we owed your program over \$1000. End of February 2019 we received a letter indicating my son would be removed from the program on March 5th, if we did not pay the amount due. We thought this would be extreme were our 5 year old would have been removed if we couldn't pay and he would have been devastated, so we immediately gathered the money and paid 100%, now, we're in a tough situation with the current pandemic, and needing this money returned as our son is home as well my daughter and we're spending hundreds more a month on food and bills.
- Kristen Reynolds, President of the Winthrop teachers Association, Third Grade Teacher: I want to take a minute to publicly thank all of the staff of the Winthrop Public Schools for their continued hard work and dedication to the students and families of Winthrop during this difficult time, while also dealing with the effects that COVID-19 are having on our own families. The members of the Winthrop Teachers Association have been working closely with the Superintendent and other administrators to put together a

plan for Remote Learning that follows the guidelines that the Commissioner of Education has released. Over the next few days, we will continue to adapt our Remote Learning Plans to account for the updated guidelines that were released by DESE on Friday. We would like to thank to School Committee and families of Winthrop for their patience as we learn how to teach in a whole new way and adapt to these new ways to connect with and engage our students. The educators in Winthrop miss our school children tremendously. Although we expected and understand the need for the school shut down to continue through the end of the school year, we heartbroken that we will not be able to welcome our students back to our classrooms and enjoy the rites of spring that the end of the school year usually brings to students at our various grade levels.

• Julia Wallerce: How will the new budget, as proposed, impact class sizes and teacher ratios? Should we expect to see cut to "specials" like art, music, and science?

The Superintendent commented that there will be no cuts if the needs budget is approved, potential cuts with a level service budget and cuts and reductions in specials with a below level service budget.

#### BUDGET

Superintendent Lisa Howard presented the committee with a Budget Process Review slideshow, a copy of which is on the school website. The FY21needs based budget is \$23,989,083.00.

# **GENERAL REPORTS**

#### Superintendent's Report

Initial 2 Week Closure March 13th: This first week, "Phase I" we prioritized student and staff safety, nutrition, and other foundational needs. We posted learning opportunities for our students and began a self-assessment of our own district in terms of technology and access to support services and learning programs.

On March 26th, in parallel with the Governor's announcement that school closures were extended until at least May 4, we began "Phase II" with a review of the DESE initial guidance on remote learning. That initial guidance was utilized in the building of a more structured Remote Learning Plan that included a focus on deeper learning of previously learned standards in grades K-8 and a continuation of teaching new standards in grades 9-12. This plan also included scheduled opportunities for students to connect with adults and peers, and to practice, process, and reflect on lessons and activities that were provided PreK- 12.

On April 22<sup>nd</sup>, given the Governor's extension of school closures through the end of the school year, The DESE has published a second round of remote learning recommendations to help districts and schools begin "Phase III." In Phase III, school districts are now asked to continue to enhance and refine their remote learning plans and expand the K-8 RL by incorporating specific power standards that will be necessary for students to successfully transition into the next grade in the Fall.

While DESE is not expecting teachers to cover all grade level standards this year, they are now asking you to go further than before. Our Teams are in the process of reviewing the guidance and building lessons and opportunities that will focus on the prerequisite standards most critical to student success in the next school year will best support our students' learning.

<u>Collaboration</u>: We have teams working within our school and across the district to develop a school and system wide approach. At the district level, we continue to collaborate with our neighboring districts, who have developed plans like our own. We will continue to do so in the coming days, as well as working to interpret guidance from the DESE.

Technology Deployment: As a public-school district, it is essential that we ensure that all our students have access to the learning that can occur. One aspect of this is access to a device. We are continuing to identify families who need a device and deliver it to them.

All of this will help us prepare for our final phase of this work – "Phase IV" – when students and staff will re-enter school. In that phase, we will also need to support students with unfinished learning and prioritize additional supports to help catch them up.

Superintendents and principals have had the challenge of responding to those who say there is not enough remote learning and others who say the volume of lessons and assignments is overwhelming. Educators, many of whom are also navigating personal challenges caring for their own children and other loved ones, are doing their best to move learning forward while supporting students' social emotional needs, often well into the evening hours. And parents and caregivers are navigating the instructional experience with teachers and students, all while balancing their own work and personal responsibilities. As this crisis continues, we must all pull together to reduce the pressure on each of us in our respective roles.
